Course Aims

Completing a Final-Year Project provides the advanced research, writing, and project management training required to work in the field of art history, either as a postgraduate, or in industry. Over a period of two semesters, students will learn to conduct a literature review, identify a research gap, develop potential research questions, discover a claim, conduct fieldwork, and write a coherent and comprehensive thesis in the field of art history. The results will be presented both as a written report and as a poster presentation. The written report can then be used as part of a research portfolio for future job applications and for post-graduate applications.

Intended Learning Outcomes (ILO)

By the end of this course, you (as a student) would be able to:

1. Develop research questions based on your literature review and research gap that you have identified.
2. Select methodologies appropriate for your chosen research topic and question.
3. Develop advanced research skills appropriate for your chosen research topic and question.
4. Apply visual analysis, contextual analysis, and theoretical analysis skills learned over the past three years to develop a claim.
5. Present your research findings both in a written thesis, oral presentation, and a poster presentation (optional) for the ADM FYP show.

Course Content

Course content will vary depending on the faculty member the student wishes to work with, and the subject they wish to do their research on.

Reading and References

Reading materials will be specific to each project. Suggestions for wider reading will be given by the faculty supervisor. Students will also be required to complete a literature review, which will reveal many of the key texts applicable to your project.
